Information Sheet

CLASSES and FEES

All classes run for 1hr with the exception of the Mini Jets Singing/Acting which is a combined class for 1.5hrs. All other classes are individual. Cost of each class is \$11.00 per hour class (including Jet Setter Hip Hop), with the exception of Mini Jets Acting/Singing \$16.50 (1.5hrs) and Jet Setters Acting and Singing \$12.10 per 1hr class payable by the term. An invoice will be issued out to students during the first week of term for the full terms fees and enrolment fee if applicable.

Payments are due by no later than week 3 (in order to keep admin costs down) of each term otherwise a 10% late fee will be charged in week 4. If payment is still not received by week 5 an additional 5% fee will be added on each week until payment is received. Please notify JETS with any issues.

All missed classes will be charged for with the exception of extreme illness or injury at the discretion of JETS. In the unlikely event fees have not been received by week 6 of term the student may not be able to attend classes. As there are limited classes and places at JETS we need to ensure full fee paying placements to keep overall class costs down. Sorry for this notice but hopefully it will not have to be enforced.

ENROLMENT FORM

The enrolment form needs to be signed once this notice is read and accepted and a fee of \$20.00 is to be paid. If student's friends wish to trial a class an enrolment form needs to also be filled out and a fee of \$11.00, \$12.10 or \$16.50 is to be paid for the trial class (enrolment fee not needed for trial class however fee is payable upon decision to join). Trial students accepted only if position available. Please keep disclaimer for personal records after accepting and signing form.

PARENTS

Parents are unable to watch classes but will be given opportunities for parent viewing throughout the year. JETS will notify parents on these occasions (towards end of term 2 is our major parent viewing). There are viewing windows for you to see classes in action but you are unable to sit in the classes with us.

UNIFORM

Jets colours are black and silver. Black pants, shorts and tops. Joggers any style. JETS has dancewear, t-shirts and track suits with logo available for purchase but not compulsory to buy. End of year Performance may need purchase of uniform. Fashion jewelry should be kept to a minimum. With all students wearing the same attire we can focus on tuition rather than competing with fashion. No skirts, thongs or sandals as this prevents free movement and feet need to be protected. Uniform is compulsory please.

BEHAVIOUR

JETS promotes a positive learning environment. We would like to maintain a caring and fun learning experience where all students deserve to be seen and heard. Bullying in any form, gossiping and intimidation will not be tolerated. Any problems arising will be handled with care and resolved

immediately. Jets policy is a letter sent home with third warning and if unacceptable behaviour continues, student may be asked to leave.

DUTY OF CARE

All care is taken during classes and no responsibility is taken for accidents or injuries incurred. Participation in all classes is at own risk. eg. Little Johnny decides to act like Superman in Acting and Ros tells Johnny he can't fly but he decides to throw himself across the room anyway and breaks an arm.....Dramatically speaking!)

END OF YEAR PERFORMANCE

Performance is scheduled for Sunday the 5th December . A Dress Rehearsal is compulsory and is tentatively booked for Sunday the 28th November (time to be confirmed). This is subject to change. A showcase of all students in all classes. Tickets will need to be purchased. Tickets go on sale term 4 along with DVD orders of the Performance. No videoing is allowed.

PHOTOGRAPHY

From time to time throughout the year, photographs and/or video footage may be taken during Classes. This may be used for power point presentations during end of year show, newsletters and occasionally advertising. If this is a problem please make a note on the enrolment form.

CONTACT

Although classes are held at Arena Joondalup JETS does not have an office at Arena. Ros can be contacted on 9405 7987 or 0413 595 189. JETS mailing address is PO BOX 1468 JOONDALUP 6919.

Contact hours at Arena Joondalup where Ros can speak with you in person is on Fridays from 4-9PM during Hip Hop classes just outside the Captains Club Room. Teachers cannot speak with you during class time. We do however understand that sometimes it may be necessary for parents to speak briefly with us over important issues which may affect your child during the class we are teaching at the time. We gladly accept notes to keep interruptions to a minimum.

On some occasions for hip hop we conduct the classes on the basketball courts. We try to get notices to you when this is going to happen, but sometimes the notes do not get to you. Therefore if we are not in our usual room please find us on the courts.

AFTER CLASS STUDENT COLLECTION

Jets cannot be responsible for students after class is finished. While we take care not to let students go home with anyone other than parents unless given prior authority, we appreciate prompt pickup or a phone call notifying of a delay in collecting your child.

WITHDRAWING FROM CLASSES

Once you have enrolled in JETS the enrolment fee covers the whole year therefore you are signing to accept a place FOR THE WHOLE YEAR. If you will not be coming back the following term, please notify JETS of your intentions as we usually have students on a waiting list for enrolment in classes.

If we do not receive notification IN WRITING we assume the enrolment is for the whole year. YOU WILL BE CHARGED FOR THE TERM if written notice is not given PRIOR to the commencement of the following term. Upon signing this document you accept these terms of enrolment AND CONTRACT

TERMS AND CONDITIONS OF JETS 2010 (please sign and return)

These Terms and Conditions form part of all trading arrangements between the School and the Parent/Student for the Services of the School for the Student on the authorisation of the Parent/Student/Custodian.

1. DEFINITIONS

In the following Terms and Conditions "the School" relates to ourselves and any related body corporate of the Supplier within the meaning of Section 50 of the Corporations law; 'the Parent' or 'Student' means the applicant and/or Custodian of the Student to whom we are supplying tuition; and "the Services" means the tuition, training, instruction the School provides to the Student.

2. PRICE

Unless otherwise specifically stated, any prices quoted by the School at which the Parent/Student accept at the time are in Australian currency.

3. PAYMENT

a) The Terms of trade is that an Invoice will be issued at the start of week 1 of the term and will be due and payable within 7 days.

b) Payment if not received at the start of week 4 will accrue a 10% levy. If still unpaid at the

start of week 5 an additional fee shall accrue on the balance at 5% of the total per week until paid.
